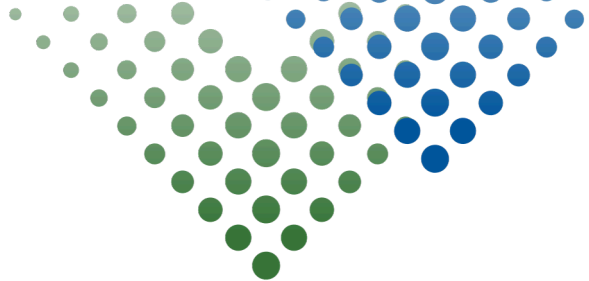


A One-day Capacity Building on **Process Safety Management (PSM)** **Implementation**
