The relevance of institutions in disaster risk governance cannot be ignored, as they play a pivotal role in shaping and executing effective strategies. Here are key institutions working at National and State level in the country:

- 1. National Disaster Management Authority
- 2. National Institute of Disaster Management
- 3. State Disaster Management Authority e.g. GSDMA
- 4. State Institute of Disaster Management e.g. GIDM
- 5. NCC/NSS
- 6. National Disaster Response Force/ State Disaster Response Force
- 7. Others like Armed Forces, Hospitals, NGOs and many more.

Case Study

Recently in November 2023, 41 workers were rescued from the Silkyara Tunnel in Uttarkashi district. Rescue operations were immediately launched, with a number of government agencies involved, including the National Disaster Response Force, the State Disaster Response Force, Uttarakhand Police, engineers from the Indian Army Corps of Engineers, and Project Shivalik of the Border Roads Organisation.
