## **Executive Summary**

Gujarat Institute of Disaster Management is organising a capacity program on ‘Disaster Risk Management through Gendered Approach’ from 22<sup>nd</sup> to 23<sup>rd</sup> August, 2024 at GIDM campus. The main aim of the training program is to spread awareness about disaster risk management among the participants and how disasters affect differently amongst different genders.

This program is targeted for the Anganwadi Supervisor (AWS) who are instrumental in implementing the Integrated Child Development Scheme (ICDS). The sessions will be delivered by experts from government, non-government organisations, academia and research institutes, etc. It will be emphasised that the pedagogy techniques will be participants-centric where they will not only learn about DRR but also get confidence to tackle any disastrous situation. The recent Wayand Landslide in Kerala, 2024 showcases the need of robust preparedness required in near future.

## **Background**

The Integrated Child Development Services (ICDS) scheme is one of the world’s largest programs for early childhood care and development. The scheme is a response to the fundamental challenges of child development in terms of a) cognitive development through pre-school non-formal education and b) physical growth by liberating childhood from the cycle of malnutrition, morbidity, reduced cognitive capacity and mortality. Through the six services offered under the ICDS: i) Supplementary nutrition, ii) Pre-school non-formal education, iii) Nutrition and health education, iv) Immunization, v) Health checkups and vi) Referral services, the Government of India aims at delivering quality nutrition, education, and health-related services to children aged 0-6 years as well as pregnant and lactating mothers.

As per NITI Aayog<sup>1</sup> report, Gujarat faces several challenges in the ICDS scheme like poor implementation, delayed reimbursement to Anganwadi Workers (AWWs); increased burden, mismatch and work load due to less ASHA and ANM; lack of skills in handling and operating online data entry, online uploading and photography; limited training for operating bureaucratic channels of communication, knowledge of how to communicate, regarding documentation and paper work. Other issues like congested Anganwadi Centres (AWCs) in urban areas, duplication and many more.

On the other hand, disasters are increasing their magnitude, frequency and intensity day by day. There is a high possibility that welfare schemes like ICDS will get affected in disaster prone areas increasing the vulnerability of children from 0-6 years as well as pregnant and lactating mothers. Regional variations like issues with storage space, areas or AWCs being prone to animal infestations can have an adverse effect on the implementation of the scheme. Hilly areas, flood prone areas have their own set of issues like accessibility, disasters and safety concerns for the beneficiaries as well as the field functionaries. Therefore, the steps taken when institutional network gets disturbed, department needs to work to deal and be prepared with disasters. As per report by Government of Odisha<sup>2</sup>, the disaster management plan needs to be prepared centering the AWC and other stakeholders.
